This schedule is not applicable to breakdown, standby, supplementary, resale, or shared service.

TYPE OF SERVICE:

Single or three-phase, 60 hertz, at available secondary voltage.

RATE:

Customer Charge

\$55.00 per Month

Plus:

\$1.00 per kVA of transformer capacity in excess of 15 kVA

-Not including shared transformers

Energy Charge

\$0.1285 per kWh

POWER COST ADJUSTMENT:

Energy sold under this schedule is subject to the Power Cost Adjustment clause on file.

MINIMUM CHARGE:

The minimum monthly charge under the above rate shall be the Customer Charge per month. No kWh's are included in the minimum charge. If revenue derived from or the duration of the prospective service is not of sufficient term to warrant the investment based on the minimum bill as determined by the Line Extension Policy, the cooperative may require an adequate minimum monthly bill calculated upon reasonable consideration before undertaking to supply service.

TERMS OF PAYMENT:

In accordance with Cooperative's Rules and Regulations.

CONDITIONS OF SERVICE:

- In the event a consumer orders a disconnection and reconnection of service at the same location within a period of twelve (12) months, the Cooperative may collect as a reconnection charge the sum of such minimum bills as would have accrued during the period of disconnection.
- Motors having a rated capacity in excess of ten horsepower (10 hp) must be three-phase unless specifically authorized by the Cooperative.

- 3. Service under this schedule is limited to loads not in excess of 50 kW. If the demand exceeds 50 kW three (3) times in a rolling twelve (12) month period, the applicable schedule will then apply. Service is accepted under this schedule for a period of not less than one (1) year.
- 4. Consumers having their home on the same premises with their business establishments may include both the home and the business on the same meter and be billed under this schedule; or, if the Consumer prefers, the Consumer may make provisions for two meters, in which case the Consumer's home will be billed on the applicable residential schedule and the usage for the other purposes will be billed under this schedule.
- 5. If it is necessary to make extensions or to reinforce distribution lines to provide service, the minimum monthly bill will be determined in accordance with the Line Extension Policy as set forth in the Rules and Regulations.
- 6. If revenue derived from or the duration of the prospective business is not of sufficient term to warrant the investment on the minimum as determined by the Line Extension Policy, the cooperative may require an adequate minimum monthly bill calculated upon reasonable consideration before undertaking to supply service. In the event, the Consumer will be required to sign an Electrical Service Agreement as to character, minimum monthly bill, and duration of business offered.
